- Alberta's forest industry is seeking alternative products/services and markets, and - Alberta's energy sector is seeking GHG emission reduction alternatives
- Forest-based, biological capture and storage of carbon is a potentially significant opportunity for the forest industry


Improved Forest Mgmt Protocol

- Improve the understanding among forest companies of the implications of realizing opportunities in the carbon economy.
- 2. Complete a realistic quantification of the feasibility of securing carbon offsets from improved forest management and afforestation.
- 3. Develop technical components required to complete improved forest management quantification protocols.

Improved Forest Mgmt Protocol

- Partnership between AFGO members and Canfor, Manning Diversified and Alberta Newsprint
- Funding is from AFGO members, above companies and FPInnovations to date. Further funding requests are underway.
- Total cost is expected to be \$200,000

Integration of Forestry-based Greenhouse Gas Emission Reduction Proposal with previous and ongoing activities.



Summary

 In summary, AFGO has been "Leading the Way" in respect to forest based carbon opportunities, offsets and credits. This will allow the forest sector to participate in the move towards Alberta seeking solutions towards the offsetting of greenhouse gas emissions from various sectors
