Introduction

The Foothills Growth and Yield Association (FGYA) was active in the following 6 projects during the fiscal year 2005-06 (April 1, 2005 – March 31, 2006):

- 1. Development and management of the Association (FRIAA¹ Project *Foothills Growth and Yield Association Second Five-Year Program* # FOOMOD-01-03);
- 2. Lodgepole pine regeneration (also FRIAA Project # FOOMOD-01-03);
- 3. Post-harvest stand development;
- 4. Cooperative management of historic research trials (FRIAA Project *Measurement and Maintenance of Historic Research Trials, #* FOOMOD-01-02);
- 5. Regional yield estimators;
- 6. Enhanced management of lodgepole pine (FRIAA Project # OF-02-16).

1. Development and Management of the Association

1.1. Income and Expenditures

Table 1 shows income and expenditures for Project 1 for the 2005-06 fiscal year. The budgeted amount is that shown in the business and work plan for 2005, with the exceptions noted. The actual amounts are as of March 31, 2006 (year end). Further details of expenditures are provided in Appendix 1.

Note in Table 1 that:

- The balance forward from 2004 and the projected expenditures include a \$10,000 grant from Alberta Sustainable Resource Development (ASRD) in support of a publication on historic research trials. An associated expenditure of \$3,130 was made (included in the contingency line of Table 1) and the balance of the grant will be expended in the first quarter of 2006. (See further explanation under Project 4.)
- A holdback of \$10,500 was released by FRIAA following the FGYA's meeting all outstanding obligations for Project FOOMOD-01-01 (FGYA first 5-year program).
- The budget for field coordination (i.e. tasks originally undertaken by the Field Coordinator) was under-spent and the budget for the Director was overspent. Both variances result from the Director undertaking field coordination tasks personally.
- The meeting and tour budget was under-spent because costs for the major technical session of the year (Post-harvest Stand Development Conference) were covered under a separate FRIAA Open Funds award.

Costs reported do not include the following in-kind contributions by members and collaborating agencies:

- Foothills Model Forest (FtMF) administrative, website-maintenance, and financial services;
- Data management services provided by the FtMF GIS Coordinator for Project 2 (estimated for 2005-06 at 24 days, value \$12,000);
- Participation on technical, steering and project committees;
- Attendance of meetings;
- Review of minutes, reports, proposals, experimental designs and scientific papers;
- Identification, inspection and registration of experimental sites.

2. Lodgepole Pine Regeneration

2.1. Income and Expenditures

Costs of treatments and field measurements were incurred directly by the member companies, and not reported to the FGYA Director. Inputs by the FGYA Director and Research and Development Associate are accounted for under Project 1 - *Development and Management of the Association* (see Table 1). The data management services of the FtMF GIS Coordinator were provided at no direct cost to the FGYA as an in-kind contribution.

2.2. Achievements and Shortfalls

Table 3 summarizes achievements and shortfalls for Project 2 – Lodgepole Pine Regeneration.

3. Post-harvest Stand Development

3.1. Income and Expenditures

The Director's time inputs were covered under Project 1 - Development and Management of the Association. Other costs incurred for the Post-harvest Stand Development Conference were covered by registration fees and a separate FRIAA Open Funds project.

3.2. Achievements and Shortfalls

The FGYA and FtMF, in conjunction with the Alberta Forest Genetic Resources Council (AFGRC) held a conference on post-harvest stand development to be held January 31 – February 1, 2006. The conference theme was integration of knowledge from the disciplines of genetics,

silviculture and forest health into the prediction of stand development, growth and yield following harvesting.

A report of the conference proceedings is in preparation and scheduled for completion June 30, 2006.

4. Cooperative Management of Historic Research Trials

4.1. Income and Expenditures

Table 4 shows income and expenditures for *Measurement and Maintenance of Historic Research Trials* (FRIAA Project # FOOMOD-01-02) during the 2005-06 fiscal year. The project covers the FGYA inputs for the overall Project 4 - Cooperative Management of Historic Research Trials. The actual FRIAA funding transfer is 10% less than budgeted in accordance with the holdback stipulated in the project payment schedule.

Alberta Sustainable Resource Development (ASRD) previously made a grant of \$10,000 towards the publication of results. This amount is not included in Table 4, but is included under Project 1 in Table 1. The grant was provided to cover editorial and partial printing costs incurred by the Canadian Forest Service (CFS) and a contractor in preparation of the compendium information report for publication. \$3,130 of the grant was spent in 2005 (included in the contingency line of Table 1) and the balance of the grant will be expended in the first quarter of 2006.

4.2. Achievements and Shortfalls

The Project involves 3 main tasks:

- 1. Maintenance and protection of the field installations;
- 2. Analysis of historic data and synthesis of results;
- 3. Ongoing re-measurement of trials.

This is a cooperative effort shared between the FGYA, Canadian Forest Service (CFS) and ASRD. The FGYA's main role is re-measurement and maintenance of the trials as specified and provided for under the FRIAA project: *Measurement and Maintenance of Historic Research Trials* (April 2003, FRIAA Project # FOOMOD-01-02).

During the summer of 2005, the FGYA undertook measurement and maintenance of 3 trials as scheduled:

- Clearwater fertilization and thinning trial;
- Strachan thinning trial (Des Crossley Demonstration Forest);
- Ricinus fertilization and thinning trial.

Achievements and shortfalls are summarized in Table 5.

5. Regional Yield Estimators

5.1. Income and Expenditures

The Director's time inputs were covered under Project 1 – *Development and Management of the Association*. No other expenditures were incurred by the Association on this Project during 2005.

5.2. Achievements and Shortfalls

An Interim Report on the Development of Yield Estimators for Pure Lodgepole Pine Stands in Alberta was prepared by Yuqing Yang and Shongming Huang of the Forest Management Branch, ASRD. The report was submitted in March 2006 in draft form to the Director and ASRD technical representative, and was reviewed with the authors. It is in the process of being edited and amended.⁴ It will be circulated to members, still as an Interim Report, with recommendations for further analysis (by ASRD) and testing of models (by FGYA members).

⁴ The report was revised and re-submitted by the authors April 26, 2006, and is now in the final stages of proof reading before being circulated to members.

6. Enhanced Management of Lodgepole Pine

This Project - *Enhanced Management of Lodgepole Pine* (FRIAA Project # OF-02-16) – is reported separately in a combined annual report and updated work plan. Income, expenditures, achievements and shortfalls for 2005 are summarized below.

6.1. Income and Expenditures

Table 6 shows budgeted and actual income and expenditures for Project 6 during the 2005-06 fiscal year.

The unspent balance is fully allocated to contracts with consultants providing field services for the 2 sub-projects.

6.2. Achievements and Shortfalls

Achievements, shortfalls and problems encountered with this project are summarized in Table 7.

The project was originally funded to a maximum of \$442,800, provided under FRIAA's *Open Funds* initiative, from April 1, 2004 to March 31, 2009. Contractors were retained to conduct fieldwork following a competitive bidding process in 2005. Based on bids received, the current project budget was sufficient to undertake installation, treatment and sampling of only 16 of the 30 candidate experimental sites identified for Sub-project 1. In order to expand the sub-project to cover the full 30 sites, the Steering Committee approved funding of an additional \$108,810 on February 23, 2006. \$40,000 was approved to be transferred in 2006 from Project 1, and the remainder to be contributed by members. Details are provided in the updated FGYA *Business and Work Plan* (April 2006).

Project 1. Development and Management of the Association

Introduction

The meeting was called to order at 1305 and the members welcomed by Don Podlubny.

Project 2 (Lodgepole Pine Regeneration trial)

Project 3 (Post-harvest Stand Development)
